# Minutes of the meeting of the parish council held on Monday 16<sup>th</sup> September 2024, 7.30 pm at Evenley Village Hall

#### 110/24 To receive apologies for absence and welcome

Apologies accepted from Matt Brown (MB) and Jean Morgan (JM). The chairman welcomed everyone and thanked them for attending.

To receive and approve for signature the minutes of the meeting of the parish council held on 15<sup>th</sup> July 2024. The minutes were approved and signed.

### 114/24 To consider a response to Acorn's public consultation on improved proposals for Astwick Green Energy (anaerobic digester) and to provide an update on actions taken by EPC

The chairman provided an update on the recent developments since EPC received a letter from Quatro, acting on behalf of Acorn Bioenergy, at the end of August. Several parishioners also received a flyer from Acorn outlining revised proposals for Astwick Green Energy and inviting them to participate in an informal public consultation.

Key dates and actions so far:

- **04.09.24**: The chairman, along with cllrs MB and SB, met with Acorn's public relations team.
- **06.09.24**: The chairman and cllr MB held a meeting with MP Sarah Bool.
- 11.09.24: A public meeting was held at Barnowl Farmshop Learning Loft.

A suggested response to the public consultation was discussed which the clerk will circulate.

It was agreed that our objections to WNC, once the application is formally submitted, should focus on three key issues: policy compliance, traffic impact, and the suitability of the location.

Please be assured that substantial work is being carried out behind the scenes to oppose this proposal.

#### 118/24 To respond to the draft Local Transport Plan consultation

People are being encouraged to share their views on a Local Transport Plan being developed by WNC. Cllr JPB attended a virtual session to learn more about the plan on 5<sup>th</sup> August and the chairman and cllr MB attended a briefing on 5<sup>th</sup> September.

One of the main aims of the plan is to connect people better; Brian Sinclair (Evenley's bus service liaison) has been instrumental in lobbying for a return of a bus service in the village; he thanked villagers for responding to the survey earlier this year organised by go-travel-solutions. Evenley features strongly in the results, so we need to keep up the pressure. On the back of Brians efforts, over the summer cllr MB wrote to WNC's head of transport asking whether they would support a link to a service Oxfordshire County Council is funding; a bus service to Bicester passing through Mixbury (operated by Ability) or support with the reinstatement of some sort of service to Brackley from Evenley. The chairman thanked Brian for his support and for persevering with this matter.

#### 119/24 To receive a quote for granite setts along the East side of the Green

The clerk has requested a quote from Raybell and Sons to edge 90m on the East side. She is awaiting a response so it will be included on the next agenda.

#### 120/24 To receive a proposal to purchase a mower for the village green

The chairman advised that the parish has faced some challenges this year, prompting the formation of a working group a few months ago to explore possible solutions.

Cllr SB explained that the parish council sought bids from around 20 contractors to handle grass cutting. However, only three contractors responded. Currently, we pay £90 per cut for maintaining the Green, but the tenders we received range from £280 to £1000 per cut. This shows that the cost of grass cutting is likely to rise significantly, by more than 50%. Moreover, the current contractor has stated they will no longer maintain the grass in Evenley after this year.

One potential solution is for the parish council to purchase a cylinder mower with funding input from the cricket club and Evenley Matters. Owning our own mower would give us more control over grass cutting on the Green and protect us from the rising costs of hiring contractors. However, we would still hire a contractor to maintain the village verges. We applied for HS2 funding to help with this, but it was declined because maintaining public open spaces is the parish council's statutory responsibility.

The cricket club has agreed to contribute £2000 towards the mower and will also cover the labour, fuel, and annual maintenance costs. We have also applied for funding from Evenley Matters, which we hope will be reviewed at their next meeting on October 22nd.

The chairman proposed we purchase a second-hand mower (with contributions) for the Green and to appoint Kris Sheppard, a village resident, to cut the verges (this tender was the preferred choice of the working group). Councillors unanimously agreed.

#### 121/24 To provide an update on the Christmas Get Together on 13th December

The event will run from 7.30pm until Midnight at Evenley Village Hall. Admission will be £5 (under 18's free) and will include entry into a raffle. Residents will need to register with the clerk and places will be available on a 'first come first serve' basis due to restriction on numbers. Any profit made will be donated to Katharine House Hospice. Promotional posters will be put up around the village and information is available on our website at: Events | Evenley Parish Council

#### 122/24 To advise on a date for the village fete 2025

The fete will be held on Saturday 6<sup>th</sup> September. Evenley Matters is organising and all help will be greatly appreciated.

#### 123/24 To agree on a location for the grit bin, Church Lane

The current placement of the bin, located in front of the allotment wall, has been causing access issues, especially when cars park opposite it. This has been particularly problematic for larger vehicles, such as agricultural machinery, and recently, a passing vehicle struck the bin. While the bin has since been moved to a safer location, as it is owned by WNC, the clerk will report the issue and request its relocation to a more appropriate spot.

- **b. Evenley Common** cllr CR has cut the grass and trimmed the inside of the hedge. He will attend to the rest at a later date.

- **e. Village Hall** the chairman met with the VH chairman after receiving bus shelter plans from the architect. This was followed up with an email raising concerns about sightlines etc; the chairman will respond.
- **f. Website** the clerk advised our old website is still live despite requests to remove it. Please add the new one to your favourite's list Evenley Parish Council.
- **g. Village Green and Trees** it was noted some of the trees need trimming back. The chairman and cllr CR will see if it's something they can do or whether they need to appoint a tree surgeon. Cllr SB advised the Green is due to be aerated.
- **h. Newsletter** the autumn edition should be ready for publication next week.
- **i. HS2 & Highways** cllr MB has written to Nick Henstock, Director of Highways and Transport regarding safety issues relating to Evenley roundabout and the cycle path to Brackley.
